
1. Amendment to Limit Government Interference with Abortion.

### 2. Right to Clean and Healthy Waters

From the ballot summary: This amendment creates a fundamental right to clean and healthy waters. The amendment may be used to sue State executive agencies for harm or threatened harm to Florida's waters, which include aquatic ecosystems.

## **DeSantis antics alienating migrant workers (and employers)**

## **GOP** legislators are begging undocumented workers to keep working in Florida.

**As Gov. Ron DeSantis** spent more Florida tax dollars flying migrants out of Texas, Republican lawmakers back home were begging migrant workers to stay in their jobs here in Florida.

**In a remarkable video** that surfaced Monday, GOP legislators Rick Roth and Alina Garcia begged migrant workers in South Florida to ignore the new immigration crackdown law that both of them supported, promising it was more tough talk than serious action.

**Roth said the immigration law** he supported "is more of a political bill than it is policy." "This bill is 100% supposed to scare you," he said. Garcia agreed, swearing the new law "really doesn't have any teeth."

**The two hoped Hispanic faith leaders** would urge their followers to keep working in Florida so that the state's tourism, agriculture and construction industries won't collapse.

**It was a bizarre scene.** And it got even more bizarre when Roth, a farmer himself, said farmers were "mad as hell" about the law. "I'm a farmer, and the farmers are mad as hell," he said. "We are losing employees. They're already moving to Georgia and other states."

None were angrier about this bill than those who voted for it.

**The odd exchang**e underscored an ugly hypocrisy about Florida Republicans' immigration rants: They want their base to believe they're furious at undocumented workers, but also want to keep those workers on Florida job sites.

**The fact that DeSantis** keeps running his multi-million-dollar migrant flight operation out of Texas — and not the state he actually runs — is more evidence of that.

**Think about it.** Conservative estimates suggest there are more than 700,000 undocumented immigrants in Florida. The American Farm Bureau says more than half its industry's workers — as many as 70% — are undocumented.

**DeSantis corporate donors here in Florida** — the ones who rely on illegal labor to maintain their profit margins — are certainly appreciative. Just as they are about the fact that DeSantis' new immigration law largely gives a free pass to Florida companies that hire undocumented workers.

## SOUTH CAROLINA TO CALIFORNIA: A 2,985-MILE BICYCLE ODESSEY

**F**or a summer break, I invited my friend, Ed from Charleston, to share some of his thoughts and observations of the bicycle trip he and three of his buddies made earlier this year. Ed is 76 and his first love is hiking followed by biking. He was also an army medic in Vietnam. Enjoy! Joe Tobin

**Physically, mentally and logistically prepared**, my friend and I left Charleston on March I and biked to Georgia where a third cyclist joined us. The fourth team member joined us in Florida. Since we could not use the major inter-state highways, we had to cycle on the older and less-used routes through cities and towns and lots of farmland. I nicknamed these southern roadways the "BBQ roads" as southerners certainly like their barbeques across their states.

**Cycling through Mississippi and Louisiana** was a definite eye-opener -- economic extremes from literally dirt poor to immense wealth. The roads themselves ranged from good to very poor. Crossing the Mississippi on the John James Audubon bridge, between the two states, was a magnificent and breathtaking experience – especially on a bike. The river itself is so much a part of American history.

The big ride was still ahead of us -- Texas. Most people consider Texas a state, but to me it is a continent. We spent twenty-one days crossing Texas. In some respects, it is two states – the hill country in the eastern portion (which is really the South) and the flatlands and mountains of the west (the beginnings of the West). In Texas we were also introduced to the immigration issue and the presence of the border patrol -- evident for the remainder of the trip.

The southern routes across New Mexico, Arizona and California were the most scenic: majestic mountains to sand dunes and

barren desert to lush agriculture. The weather patterns included a flow of west winds and temperatures that ranged from very hot to very cold. But we survived them.

**Despite the media talk about divisions in America**, the people we met along the way were very supportive of us, especially if we needed help with flat tires (of which there were many), broken chains or emergency transportation. When the local folks were around us, we felt safe and comfortable.

Many asked us why we were undertaking this ride. In turn, we had lots of questions for them and about their lives in these small towns and cities. Was surprised to learn how many people we spoke to never traveled beyond their county lines.

**There were two elements** that were common to almost every geographical area: (i) the disparity of wealth versus poverty; and (ii) everybody had cell phones (wonderful to have on a cross-country trip).

**Once we started** approaching the Gulf of Mexico waters, we could see in the distance the oil rigs standing tall in the Gulf waters and then dotting the corporate oil fields. There were also wind and solar tracts dedicated to the production of energy. Texas and Louisiana are so important to the production of energy for the American public.

When I hit Dog Beach in California I was exhausted in all ways. When asked how I felt nearing completion, my response was "like mile 20 of a marathon, you are reaching inside for the juice to finish"! When asked how I felt when I braked and jumped off the bike, I could only say "relief and elation"!

**Looking back**, I was glad I took on the challenge (as did my buddies). What strangely amazed me the most was something very simple: the struggle of flora and fauna to survive in such extreme harsh conditions, whether it was a weed growing in a pavement crack or an immigrant fleeing across the border in search of a better life. After all, part of life is meeting challenges head on.

Thank you for this opportunity to tell my and my buddy's story. — Ed & Joe



# NATIONAL 'TICS Fact-checking the FACTS!

A s Donald Trump headed toward his classified documents indictment in Miami this week, his Republican supporters came to his defense, comparing Democrats' handling of classified, or would-be classified, materials with Trump's. They argued that Trump was punished when Democrats weren't. But experts told PolitiFact the cases aren't parallel and have important differences. Here are three examples.

1. Hillary Clinton's emails. Sen. Lindsey Graham, R-S.C., referred to an investigation into Trump's 2016 Democratic opponent Hillary Clinton and her handling of classified information. "Most Republicans believe we live in a country where Hillary Clinton did very similar things and nothing happened to her," Graham said. The FBI investigated Clinton for using a private email server as secretary of state. Then-FBI Director James Comey said of the 30,000 emails the FBI investigated, 113 were determined to have contained classified information when they were sent. The FBI didn't charge Clinton; Comey said she handled classified information carelessly, but there was no evidence she intended to break the law. The federal indictment against Trump, by contrast, shows he knew he had classified documents stored at Mar-a-Lago, his Florida estate. The Trump indictment lays out how Trump stymied the federal government's efforts to recover them. Read more.



### 2. Joe Biden's classified documents.

Sen. Ted Cruz, R-Texas, said Trump was indicted by a special counsel for having classified documents while President Joe Biden hadn't been. Cruz tweeted, "Joe Biden did the exact same thing, and the DOJ doesn't care!" CBS News reported that lawyers in November 2022 discovered documents, some with classification markings, in a locked closet in Biden's post-vice presidential office at the Penn Biden Center for Diplomacy and Global Engagement in Washington, D.C. The Justice Department appointed a special counsel to investigate Biden's handling of classified documents, just as the department did for Trump. Experts told PolitiFact the Trump case sets a high bar for seriousness and has a number of extraordinary circumstances the Biden case so far lacks — particularly a failure to return the documents once they were discovered. <u>Read more.</u>

**3. Bill Clinton's sock drawer.** Trump told a Columbus, GA, crowd, that government officials don't mention the lawsuit brought against Bill Clinton...the famous socks case that says he can keep his documents. When Clinton was president, historian Taylor Branch interviewed him to create an oral history of his presidency; news outlets wrote that Clinton kept interview audiotapes in his sock drawer. *Judicial Watch,* a conservative group, sued the National Archives and Records Administration back in 2010, asking the court to declare the tapes presidential records. But U.S. District Court Judge Amy Berman Jackson dismissed the case, saying the law distinguished the tapes as "personal records," distinct from "official" records. The records Trump took to Mar-a-Lago, by contrast, "appear to overwhelmingly contain records pertaining to the official business of the White House." <u>Read more.</u>
