# FRIENDS, FOOD AND FUNDS – SOLIVITA VOLUNTEERS STEP UP

**I**n December 2007, the Great Recession was about to send the national economy into a tailspin that included high unemployment for local Poinciana workers, especially those who worked at Disney. Families were knocking at the office door of St. Rose of Lima parish (“parish”) and seeking food assistance. Seeing a need, a small group of volunteers started the Food Pantry at the church.

**Jim and Martha Cusimano moved to Solivita in 2008.** As parish members, this couple decided to help the Food Pantry by enlisting Solivita residents to volunteer at the Food Pantry. Their first step was to form a Solivita club that they named “DUO” or shorthand for “Do Unto Others.”

**This couple believes their interest in starting DUO** may stem from their Irish and Italian backgrounds: the Irish heritage of Martha always included an account of the great famine of the 1840s that caused so many Irish to migrate to America; and Jim remembered his Italian mother’s motto that “nobody leaves the table hungry.”

**The early days of the Food Pantry, DUO and the parish** were a learning experience for the volunteers. The operation of



any food bank includes the collection, distribution and storage of food, organization of workers, raising funds and public relations if it is to be successful. Thanks to persistence and hard work, the continued sponsorship of the parish and lots of dedicated volunteers, the Food Pantry has thrived and expanded for seventeen years.

**When the new parish church on Pleasant Hill Road was opened,** it made the food distribution easier and more convenient for families, thanks to the continued support of individual Solivita donors, Second Harvest of Central Florida and U.S. Representative Darren Soto. Over a sixteen-year period, DUO has raised more than \$500,000.00 on behalf of Food Pantry from donors.

**From the experience of the Great Recession,** the staff of the Food Pantry successfully met COVID-19 with efficiency, distributing over 310 tons of food to more than 80,000 people. In recent years, the Solivita administration has been most cooperative in supporting the organized collection of food and acceptance of checks on

designated days for St Rose's and St. Ann's food pantries.

**A**t the request of Representative Soto, Martha testified before the Congressional Hispanic Caucus, invited representatives of congress and the Biden administration. Martha briefed Congress members on both the local program at St. Rose of Lima and the importance of the food banks in general. She also stressed the

necessity of federal financial assistance through the Farm Bill budget to maintain and update foodbank infrastructures across the country, such as the need for refrigerated storage.

**One goal of the parish is to build the Lima Center** – a 9000-square foot building that includes space for a parish meeting room and the Food Bank operation. Design plans are already in place and building permits were pulled in December 2023. Breaking ground is scheduled for late 2024.

**As members of the Solivita Democratic Club**, we salute the work of Martha and Jim – and all the volunteers, especially our Club members – who make the two local food banks a such a wonderful contribution to the communities of Poinciana and Haines City.

**2024 HOA BOARD OF DIRECTORS ELECTION**

**I**n accordance with the Association's Bylaws and Florida Statute 720, the Association's Annual Meeting of the Membership has been scheduled as follows: 10:00 AM, Tuesday, Feb. 20, 2024 in the Solivita Starlite Ballroom, 384 Village Drive. Members will vote to fill two open Board of Director positions, each with a two-year term. In accordance with the procedure for director nomination, the candidates must give the Association written notice of their intent to run for the office, along with a completed candidate certification form signed by the candidate, no later than Thursday, November 16, 2023.

**No candidate nominations may be accepted from the floor** at an Annual Members Meeting. All candidates must meet the eligibility requirements as stated in Florida Statute 720 at the time of the deadline for submitting the notice of intent to be a candidate.

**Members will also vote on the seven proposed amendments** to our governing documents

**Lita Epstein, one of our own SDC members, is running for the Solivita HOA Board**

**As a resident of Solivita since 2005, she has worked on many projects to further the development of the community including:**

**Save Our Solivita (2008/2009):** helped to organize and participate in this working group to oppose the incorporation of the city of Poinciana and prevent Solivita from becoming a cash cow for the property taxes of the city.

**Beginning in Sept. 2015,** she worked diligently to prevent the amenities purchase for \$73 million, including serving on the CDD beginning in 2016 and becoming chair in 2018 to prevent the closing of the contract to purchase the amenities for \$73 million.

Organized the campaign in 2018 of five CDD members called the **Price is Too High** to help fight the purchase of the amenities for \$73 million. Won by more than 67% of the vote.

**Organized and continue to coordinate the Southport Connector Alternative Routes (SCAR),** to seek an alternative to the plan for building a Great Wall of Poinciana outside our gates.

**Filed a Title VI complaint** to slow the process for the Southport Connector and seek federal investigation of its planning.

**Served on the Poinciana CDD** for 7 years, including five as Chair.

Served on HOA boards, including as President, in 4 states.

Served Community Planning boards or Committees in 4 states, including the Polk County's Planning Commission and Board of Adjustments.

Business owner and author with 50 books on the market primarily in the areas of business and personal finance.

# The conspiracy theory campaign of Robert F. Kennedy Jr. is PolitiFact's Lie of the Year

**A**s pundits and politicians spar over whether Robert F. Kennedy Jr.'s presidential campaign will factor into the outcome of the 2024 election, one thing is clear: **Kennedy's political following is built on a movement that seeks to legitimize conspiracy theories.**

**His claims decrying vaccines** have roiled scientists and medical experts and stoked anger over whether his work harms children. He has made suggestions about the cause of COVID-19 that he acknowledges sound racist and antisemitic.

**Bolstered by his famous name** and family's legacy, his campaign of conspiracy theories has gained an electoral and financial foothold. He is running as an independent — having

abandoned his pursuit of the Democratic Party nomination — and raised more than \$15 million. A political action committee pledged to spend between \$10 million and \$15 million to get his name on the ballot in 10 states.

**Even though he spent the past two decades** as a prominent leader of the anti-vaccine movement, Kennedy rejects a blanket “anti-vax” label that he told Fox News in July makes him “look crazy, like a conspiracy theorist.”

**But Kennedy draws bogus conclusions** from scientific work. He employs “circumstantial evidence” as if it is proof. In TV, podcast and political appearances for his campaign in 2023, Kennedy steadfastly maintained:

**Kennedy claims vaccines cause autism.**

**No childhood vaccines** “have ever been tested in a safety study pre-licensing.”

**There is “tremendous circumstantial evidence”** that psychiatric drugs cause mass shootings, and the National Institutes of Health refuses to research the link out of deference to pharmaceutical companies.

**Ivermectin and hydroxychloroquine** were discredited as COVID-19 treatments

so COVID-19 vaccines could be granted emergency use authorization, a win for Big Pharma.



**Exposure to the pesticide atrazine** contributes to gender dysphoria in children.

**COVID-19 is “targeted to attack Caucasians and black people.** The people who are most immune are Ashkenazi Jews and Chinese.”

**For Kennedy, the conspiracies aren’t limited to public health.** He claims “members of the CIA” were involved in the assassination of his uncle, John F. Kennedy. He doesn’t “believe that (Sirhan) Sirhan’s bullets ever hit my father,” Sen. Robert F. Kennedy, D-N.Y. He insists the 2004 presidential election was stolen from Democratic candidate John Kerry.

**News organizations, including PolitiFact,** have documented why those claims, and many others, are false, speculative or conspiracy-minded.

**Kennedy has sat for numerous interviews** and dismissed the critics, not with the grievance and bluster of former President Donald Trump, but with a calm demeanor. He amplifies the alleged plot and repeats dubious scientific evidence and historical detail.



**Will his approach translate to votes?**

According to polls since November of a three-way matchup between President Joe Biden, Trump and Kennedy, Kennedy pulled 16% to 22% of respondents.

**Kennedy’s movement exemplifies the resonance of conspiratorial views.**

Misinformers with organized efforts are rewarded with money and loyalty. But that doesn’t make the claims true.

**Robert F. Kennedy Jr.’s campaign is so based on false theories that it is PolitiFact’s 2023 Lie of the Year.**

**When he’s asked about his views,** Kennedy calmly searches his rhetorical laboratory for recycled talking points, selective research findings, the impression of voluminous valid studies, speculation, and inarguable authority from his experience. He refers to institutions, researchers and reports, by name, in quick succession, shifting points before interviewers can note what was misleading or cherry-picked.

**There is power in repetition.** Take his persistent claim that vaccines are not safety tested.

**In July, he told “Fox & Friends,”** “Vaccines are the only medical product that is not safety tested prior to licensure.”

**On Nov. 7 on “PBS NewsHour,”** Kennedy said vaccines are “the only medical product or medical device that is allowed to get a license without engaging in safety tests.”

**On Dec. 15, he told CNN's Kasie Hunt** that no childhood vaccines have “ever been tested in a safety study pre-licensing.”



**All of this is false!** Vaccines, including the COVID-19 vaccines, are tested for safety and effectiveness before they are licensed. Researchers gather initial safety data and information about side effects during phase one clinical trials on groups of 20 to 100 people. If no safety concerns are identified, subsequent phases rely on studies of larger numbers of volunteers to evaluate a vaccine's effectiveness and monitor side effects.

**Kennedy sometimes says that some vaccines weren't tested** against inactive injections or placebos. That has an element of truth: If using a placebo would disadvantage or potentially endanger a patient, researchers might test new vaccines against older versions with known side effects.

**But vaccines are among “the most tested and vetted”** pharmaceutical products given to children, said Patricia Stinchfield, a pediatric nurse practitioner and the president of the National Foundation for Infectious Diseases.

**Kennedy encourages parents to research questions on their own,** because doctors and other experts are invariably compromised.

**“They are taking as gospel what the CDC tells them,”** Kennedy said on Bari Weiss' “Honestly” podcast in June.

**Public health agencies have been** “serving the mercantile interests of the pharmaceutical companies, and you cannot believe anything that they say,” Kennedy said.

### **Experts fret that the Kennedy name carries weight.**

**“When he steps forward and he says the government's lying to you,** the FDA is lying to you, the CDC is lying to you, he has credence, because he's seen as someone who is a product of the government,” said Dr. Paul Offit, a pediatrics professor in the Children's Hospital of Philadelphia's infectious diseases division and the director of the Vaccine Education Center. “He's like a whistleblower in that sense. He's been behind the scenes, so he knows what it looks like, and he's telling you that you're being lied to.”

**P**resented to the club member who has consistently demonstrated throughout the year the true spirit of our Democratic Ideals through the Education, Communication and Motivation of Solivita residents.


